## KWIH to Launch “K. Wah Cares” Vaccination Incentive Campaign on 6 July

(Hong Kong - 2 July 2021) – The “**K. Wah Cares**” **Vaccination Incentive Campaign** launched/created by **K. Wah International Holdings Limited (“KWIH” or “Group”) (Stock Code: 00173)** will accept registrations from 6 July 2021 onwards. Hong Kong Identity Card holders who receive the first or second dose of a COVID-19 vaccine between 6 July 2021 and 29 August 2021 are eligible to participate in the lucky draw. They must access the campaign web page on the day of their vaccination (<http://kwahcaresvaccination.kwih.com>) to complete the registration process. The campaign aims to encourage citizens to get vaccinated as soon as possible, boosting the vaccination rate and building an anti-pandemic barrier to protect the city. KWIH will be distributing InterContinental Grand Stanford Hong Kong electronic dining vouchers worth a total of HK\$1 million. The key dates for the lucky draws are as follows:

Moreover, the Group previously announced that it would donate HK\$1 million to subsidise pre-vaccination medical check-up fees, transportation fees and other related expenses including those who have to take leave from work for vaccination, to be recommended and screened through the Tung Wah Group of Hospitals ( “TWGHs” ). Students, service users of TWGHs and their direct family members are eligible for the subsidy. The Board of Directors (2021/2022) of TWGHs will also donate HK\$1 million to the same cause to benefit more underprivileged individuals. Each qualified applicant when approved will receive a subsidy of HK\$500. The application period will start on 12 July 2021. For further details, please visit the TWGHs website nearer the time.
